1. CALL TO ORDER

Chairman Gallagher called the meeting to order at 1:07 p.m.

WHEREAS, Cuyahoga County received \$239,898,257 from the Federal Government through the American Rescue Plan Act ("ARPA"); and

WHEREAS, Cuyahoga County calculated 100% of the ARPA dollars as loss revenue under the U.S. Department of the Treasury Final Rule; and

WHEREAS, since all the ARPA dollars have been calculated as loss revenue, the ARPA dollars have been deposited in the County's General Fund; and

WHEREAS, the County Executive and County Council have authorized \$86 million of the ARPA dollars for community grants to benefit the residents of Cuyahoga County (the "ARPA Community Grant Fund"); and

WHEREAS, of the \$86 million for community grants, \$66 million have been encumbered for equal distribution to each County Council District; and

WHEREAS, the Cuyahoga County Council desires to provide funding from the District 3 ARPA Community Grant Fund in the amount of \$50,000 to the Catholic Charities Corp. for the purpose of the Migration and Refugee Service Immigration and Legal Services program; and

WHEREAS, the Catholic Charities Corp. estimates approximately 1,500 people will be served annually through this award; and

WHEREAS, the Catholic Charities Corp. estimates approximately 7 permanent and temporary jobs will be created or retained through this project; and

WHEREAS, the Catholic Charities Corp. estimates the total cost of the project is \$1,856,803; and

WHEREAS, the Catholic Charities Corp. indicates the other funding source(s) for this project includes:

- A. \$40,000 from Community West
- B. \$50,000 from The Gund Foundation

WHEREAS, the Catholic Charities Corp. is estimating the start date of the project will be April 2024 and the project will be completed by March 2025; and

WHEREAS, the Catholic Charities Corp. requested \$50,000 from the District 3 ARPA Community Grant Fund to complete this project; and

WHEREAS, the Cuyahoga County Council desires to provide funding in the amount of \$50,000 to the Catholic Charities Corp. to ensure this project is completed; and

WHEREAS, this Council by a vote of at least eight (8) members determines that it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue to provide for the usually, daily operations of the County.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the Cuyahoga County Council hereby awards a not-to-exceed amount of \$50,000 to the Catholic Charities Corp. from the General Fund made available by the American Rescue Plan Act revenue replacement provision for the purpose of the Migration and Refugee Service Immigration and Legal Services program.

SECTION 2. If any specific appropriation is necessary to effectuate this agreement, the Director of the Office of Budget and Management is authorized to submit the requisite documentation to financial reporting to journalize the appropriation.

SECTION 3. That the County Council staff is authorized to prepare all documents to effectuate said award.

SECTION 4. That the County Executive is authorized to execute all necessary agreements and documents consistent with said award and this Resolution.

SECTION 5. If requested or necessary, the Agency of the Inspector General or Department of Internal Audit is authorized to investigate, audit, or review any part of this award.

SECTION 6. To the extent that any exemptions are necessary under the County Code and contracting procedures, they shall be deemed approved by the adoption of this Resolution.

SECTION 7. It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health or safety in the County; and any additional reasons set forth in the preamble. PROJECT DESCRIPTION

REQUEST DESCRIPTION (include the project name, a description of the project, why the project is important or needed, and timeline of milestones/tracking of the project):

Since 1948, Catholic Charities Migration and Refugee Service (MRS) has provided services to immigrants and refugees in Cleveland from around the globe. MRS is the second largest resettlement office in Ohio, based on the number of new arrivals, number of refugees served, and programs offered.

MRS's Immigration and Legal Services ("ILS") program provides representation to marginalized immigrant community members at critical times in their lives. Whether that be seeking safety in the United States, reuniting with family members, or accessing immigration benefits as victims of crime and violence inside the United States – representation during these times is vital to an immigrant's ability to navigate the increasing complexity of our immigration system.

In 2023, ILS provided direct legal representation to 1,800 immigrants in our community. As a whole, access to legal immigration status provides immigrants a path to security, promotes safety and stability, and facilitates and increases access to community resources. As neighbors, business owners, taxpayers, and workers, immigrants are an integral part of Cleveland's diverse and thriving community and make extensive contributions that benefit all.

ILS utilizes LawLogix Edge, a case management system designed specifically for immigration law, to track and manage cases. All individuals who contact ILS for legal services are entered into the LawLogix database. LawLogix has the capability to generate immigration forms, link case reminder dates to staff calendars, generate reports, manage digital copies of documents, and track staff hours by funding source.

In the next year, ILS anticipates screening over 2,500 individuals seeking legal assistance and providing direct legal services to at least 1,500 individuals. ILS is requesting a \$50,000 grant to support the operation of our legal services program and sustain our ability to respond to the needs of our immigrant neighbors. As upcoming immigration policy changes and international crises unfold, the necessity for immigration legal services is only anticipated to grow. ILS is committed to providing such representation with care and compassion to those in our community who need us most.

REQUEST DESCRIPTION (include the project name, a description of the project, why the project is important or needed, and timeline of milestones/tracking of the project):

Title: Enhanced Home Maintenance Grant Program and Safety Forces Funding

History: In 2018 the Village of Newburgh Heights initiated a home maintenance grant for residential property owners that also lived in the Village. The program was a matching grant program that awarded up to \$1000 a year with a maximum number of 3 projects over a 5-year period awarded to any single property owner. For illustrative purposes, to receive the full \$3,000, the homeowner would have had to spend \$6000 on approved maintenance projects that improved their property as outlined by ordinance chapter 1365 of the Newburgh Heights codified ordinances. That program had contributed to more than 50 property owners at the time of the pandemic with many more eager to utilize the resources. Due to the loss of employment and/or the rapidly escalating expense of projects, many property owners have been priced out of making basic upgrades or maintenance improvements to their homes they were planning to make by utilizing the Village's grant program.

Need: By authorizing the funding for Newburgh Heights, the County Council would be affording property owners the opportunity to make the necessary improvements. Most homes in Newburgh Heights are at least 100 years old and in need of continuous investment to keep the neighborhood vibrant and attractive. This program would provide long-term dividends in the form of increased property values as well, resulting in additional tax values for the County, Schools, and Municipality, leading to a reduced need to pursue additional operating levies over time.

The recruitment crisis facing law enforcement has impacted the department where we have lost eight officers in the past two years to other agencies. It is also challenging to compete with other agencies who can offer a better financial package. As a smaller agency we previously had 15 officers but are down to nine, which has caused forced overtime and impacted officer morale. We have begun to accept lateral transfers but have had minimal success to this regard. To this end, we are seeking funding for two police officers to allow us to sustain a minimum manning of two (2) officers per eight-hour shift, seven days a week, minimize the use of overtime and improve on officer wellness and morale.

Additionally, over the past several years, our fire department budget has increased due to rising labor costs for changing from a part-time fire department with minimum of 2 (two) firefighters on duty to a full-time fire department while trying to maintain 3 (three) firefighters on duty per day for increased safety for our residents and firefighters. Cuyahoga County ARPA funds will help us retain our firefighters and maintain our daily manpower for our Village and the Cuyahoga Valley Region.

Proposed Program: The housing grant would function similarly to ch. 1365 of the Village's current grant program. The funds would be set aside in a special revenue fund to ensure its use exclusively for the program and matched by the Village of Newburgh Heights up to \$1000 per \$5000 grant awarded by the Village using the ARPA resources. For example, if a project were \$7,000, the Village would award \$5000 of the County ARPA funds, \$1000 in Village matching funds and the homeowner would contribute \$1000. A maximum of \$100,000 would be allocated each year for the next 2 years with a maximum ARPA fund grant size being \$5000. This would allow for at least 20 properties in a year if the maximum award were provided to each. The procedures outlined in ch 1365 of the Village's ordinances would be used as the basis for the review and approval criterion of the enhanced grant program. Payroll for staffing maintenance of the police and fire department would comply with State and Federal regulations.

Tracking: The Village of Newburgh Heights Housing and Building Department will be responsible for providing an annual report to the Village Council and Mayor to provide to County Council regarding the progress and investment resulting from the enhanced grant program.

The entire Village of Newburgh Heights is considered a low to moderate income target zone.

How does the project fit with the community and with other ongoing projects:

Approximately 7 years ago the village established a grant program to service the same demographic. That program would award 50% matching grants up to \$1000 for a residential property owner residing in the village. If the property owner spent \$2,000 the Village would reimburse \$1000. If the property owner spent \$1000 the Village would reimburse \$500. The program was gaining significant momentum with close to 50 participants in its first several years. Rising costs as a result of the pandemic has stalled the progress.

If applicable, how many jobs will be created or retained (specify the number for each) and will the jobs be permanent or temporary:

Each project results in the creation of at least 1 and as many as 10 temporary construction positions. At least 4 positions will be maintained in the safety forces as a result of the program.

If applicable, what environmental issues or benefits will there be:

In some circumstances it is anticipated residents will convert to fuel efficient tankless water heaters, modernized electrical systems, and solar power as the Village has just updated its solar ordinances.

If applicable, how does this project serve as a catalyst for future initiatives:

We believe this level of investment will create an upward spiraling effort to modernize, improve efficiency, and lead to ongoing sustained property maintenance investments, ultimately reenergizing the matching grant home maintenance program initiated by the Village. The resources used for this project create a long-term return on investment by improving property value, resulting in increased revenue for the County/Village/Schools and homeowner real estate values and living conditions.
